

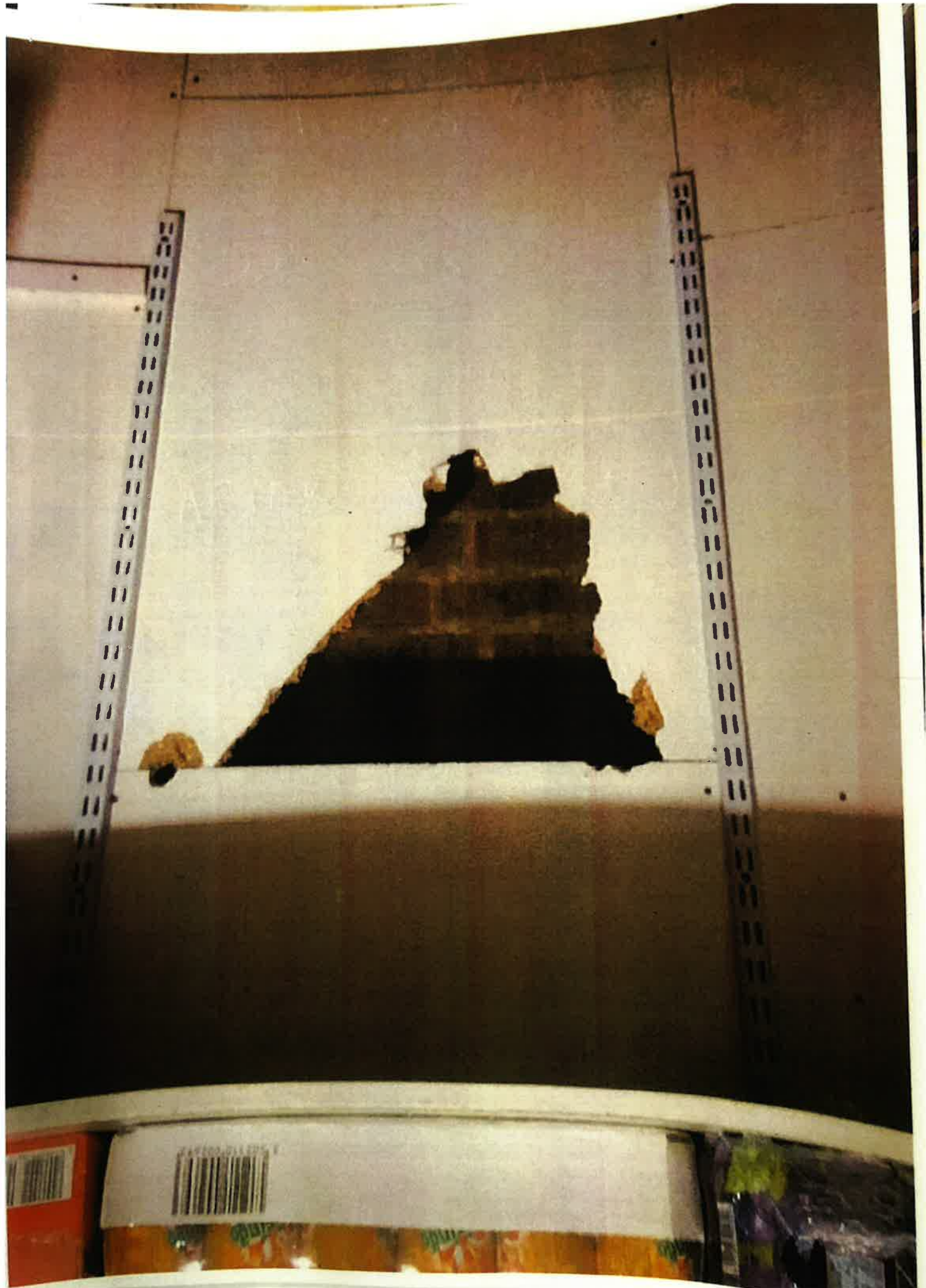

consumer Rights Act 2015 Notice

Reason for the Entry

- The entry is for a routine inspection (2 working days notice to be provided)
- It is suspected that there has been a breach of the enforcer's legislation.
- It is considered that to give a notice would defeat the purpose of the entry.
- It is suspected that there is an imminent risk to public health or safety.
- It is for the purpose of market surveillance within the meaning of Article 2(17) of the Regulation on Accreditation and Market Surveillance.
- Under Warrant (Code B Notice also required)

Offence of obstruction

Obstructing a duly authorised officer is an offence. Obstruction includes where a person intentionally obstructs an officer; intentionally fails to comply with instructions given by an officer; without good reason fails to give an officer assistance or information reasonably required; makes a statement or a reckless statement which they know is false or misleading.
