**Annex 1 - Mandatory Conditions**

- 1.1 (1) No supply of alcohol may be made under the premises licence -
  - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
  - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

## Annex 2 - Conditions consistent with the operating schedule

2.1 Alcohol shall not be sold or supplied unless suitable beverages other than alcohol (including drinking water) are equally available for consumption with or otherwise as an ancillary to meals served in the premises.

2.2 Alcohol may be sold or supplied:

- On weekdays, other than Christmas Day, Good Friday or New Year's Eve from 11am to 12pm.
- On Sundays, other than Christmas Day or New Year's Eve, and on Good Friday: 12 noon to 11:30pm
- On Christmas Day: 12 noon to 11:30pm;
- On New Year's Eve, except on a Sunday, 11 am to midnight;
- On New Year's Eve on a Sunday, 12 noon to 11.30 pm
- On New Year's Eve from the end of permitted hours on New Year's Eve to the start of permitted hours on the following day, which would be 11.00 am if New Year's Day falls on a weekday or 12 noon if a Sunday.
