- A The Section 151 Officer in consultation with the Portfolio Holder for Finance calculated the Council Tax Base 2025/26 as 29,297.58 (Item T in the formula in Section 31B of the Local Government Finance Act 1992);
- **B** The Council Tax Requirement for the council's own purposes for 2025/26 as set by Full Council on 27 February 2025 is £8,464,071;
